## Speak up for immigrants & asylum-seekers

We need everyone to speak up. You are the most important spokesperson when it comes to influencing friends & family!

People are influenced more by personal stories than facts & figures. The empathycenter of our brains turns off when we start thinking about numbers. The empathycenter turns on when we hear personal stories. But too much gloom & doom can be overwhelming & encourage us to give up. **So tell a story to illustrate the facts, ask the hearer how they would feel in the position of the immigrant in your story, & suggest a way for the listener to act on what you've told them.** The feeling of accomplishment from that concrete action will inspire the listener to do more good work!

If you receive pushback, ask questions instead of arguing. Learn what matters to the person you're speaking to and use that to encourage empathy with immigrants.

#### Facts:

- 1. The foreign-born proportion of the U.S. population is the same as it was in the late-19<sup>th</sup> century. Laws at the time ensured that most of those immigrants were white.
- 2. Output in the economy is higher & grows faster with more immigrants.
  - a. Immigrants are almost twice as likely to have doctorates; they increase innovation.
  - b. Undocumented immigrants are crucial to agriculture & industry. They keep costs down.
- 3. Immigrants are less likely to commit crimes than people born in the USA. Most illegal drugs enter the country through legal entry points.
- 4. Asylum is legal & you must already be on U.S. soil to apply for it.
- 5. Undocumented immigrants pay taxes & yet they are ineligible for government welfare benefits. Legal immigrants are only eligible for benefits after 5 years.
- 6. ICE (Immigration & Customs Enforcement) has only existed since 2003. We can have oversight without crimes against humanity.
- 7. A larger border wall is an ineffective waste of money and harmful to the environment. It won't stop humans from crossing, but it will hurt species & waste resources. We don't want open borders. We want humane, commonsense policies.

### Tips for messaging

Don't use	Use	Explanation
"illegal aliens"	"New American immigrants"	Most undocumented immigrants overstay their visa, which falls under civil—not criminal—statute. Seeking asylum is legal. "Alien" implies difference.
"give rights"	"stop unfair barriers" or "ensure freedom"	Theoretically, we already have equal rights under the law. The problem is that these rights are being denied.
"hate"	"love"	Focus on our values of love & inclusion.
"bigots"	"radicals"	Point out that we represent the norm.
"identity politics"	"bring everyone to the table"	Complaints about "identity politics" are just a way of defending the white status quo. Focus on inclusion.
"rights of prisoners"	"risk to public safety when law enforcement aren't working as allies"	Racism & for-profit detention camps encourage racial profiling (which shifts focus away from the people most likely to commit crimes) & discourage people in marginalized positions from reporting crimes for fear of law enforcement. This threatens everyone's safety.
"help the needy"	"there's enough for all of us"	Opponents divide us; calling us to care for "Americans" 1 <sup>st</sup> . Undocumented immigrants are <i>unprotected</i> taxpayers.

**See ICE or Customs Border Patrol (CBP)? Call the VT ACLU: 802-223-6304** They don't have permission to enter your premises or vehicle without a warrant <u>signed by a judge</u>. The VT ACLU is tracking their activity, so call the ACLU even if you aren't stopped or questioned.
