## **Zoom Meeting**

Chair Mary Mellow called the meeting to order at 7:05 p.m.

Treasurer's Report – No report.

Secretary's Report – The draft minutes of the August 23, 2022 meeting were sent out to the committee prior to meeting. Anna made a motion to accept the minutes. Motion seconded by Josh. Minutes accepted.

#### **Old Business:**

Headquarters: Steve Craffey, VDP Organizer will be on-site this coming week and here for open house.

Mary discussed headquarters staffing. Could we all call 10 people to work in the headquarters? Discussion of getting volunteers to canvass on weekends. Heather can help set up the groups. Steve would manage the routes. Heather could do follow-up and help organize.

Phone banking can be done in office or from home, usually Sunday or some weekday nights. VDP facilitates the phone lists. Steve will get things underway. Anna has been looking for volunteers for canvassing, phone banking, etc.

Discussion of headquarters hours. We need to set our hours and get volunteers. Mary suggests 11 a.m. until 6 p.m., with 2 hour shifts. The last shift is longer. Phone banking would last longer.
