## **Old Business:**

Web Page Calendar of Events – Discussion of our web page calendar and whether it's being used. Heather manages the calendar. She needs events sent to her. It hasn't been updated for a while.

Large and Small Banners – Need to locate both for Fourth of July parades (Brandon on 7/2, Castleton on 7/3, and Poultney on 7/4). Discussion of board members attending parades. Anna will attend the parade in Killington. Town chairs should be organizing parade volunteers. Board members will join parades in Brandon, Castleton, and/or Killington, if possible.

Justice of the Peace Filing Deadline – Mary will get the list from the VDP. The deadline is 8/12.

Discussion of committee members calling town chairs. Heather will send Mary the list which was used by board members to call town chairs for last reorganization.

Committee Email Code – Agreed to continue to use "RCDC" in the beginning of the subject line of emails.

## **New Business:**

Campaign Headquarters – Discussion of having a public place for candidate signs and materials. Don't have enough in budget. Previously shared space with Rights & Democracy. Mary will ask Scott how much should be paid, if we're able to find an available space. Committee members will look for space.
