County Lists—Mary makes an email list of the county chairs and the executive committee. She will discuss the master list with Eugenia. Mary has sent a note to Scott about Mad Mimi. The VDP will also give us a spreadsheet list for Rutland County.

Meeting will be at the Rutland Free Library—Fox Room.

Old Business:

Reorganizations Recap – Recap went well. Some towns had problems with submitting the paperwork. Mary will discuss this with the VDP.

Budget – will need to plan a budget for upcoming events (2023-2025).

Website update – Anna discussed the website progress. She, Barbara, and the tech company representative are going to have a discussion. Anna has some questions. Most of the contract looks OK. Need to look at the retainer. We need someone to do data entry and publicity. Someone needs to do a monthly update, social media posting, and we need a calendar on the website.
